A report was recently released in Canada announcing that common foods such as cereals and cookies contain residues of the chemical glyphosate. Also known by the name Roundup, glyphosate is used to kill weeds in crop fields.

Best Food Facts has asked experts over the past two years to answer a number of questions on this topic, as a similar report was previously released in the United States.

### What the Experts Have to Say

**“Glyphosate continues to be widely used because few, if any other herbicides, are as safe, effective, and economical. By safe, I mean safer than table salt.”**

**“They’ve all [pesticides] gone through extensive testing, but they are a pesticide. They are designed to kill living organisms. If they aren’t used properly, they are not safe. But that said, if products are used according to the label, the benefits far outweigh the costs, and this is true of all chemicals and pesticides, not just ones created with GMO technology”.**

## Glyphosate Regulation in Canada

- The Canadian Food Inspection Agency reports that over the last 10 years, residue data shows that the compliance rate is consistently very high for fresh fruits and vegetables.

For example, in 2015/2016 CFIA's Glyphosate Testing Revealed:

- 98.7% of grain products tested were well below Canada's maximum residue limits.
  - No samples of fruits, and vegetables, soy products or infant foods were found to contain residues exceeding Canadian limits.
- 
- Before any pesticide can be registered in Canada, Health Canada must review the scientific information to make sure that it has value and there are no health or environmental concerns related to its use.
  - Health and environmental risks are considered acceptable if there is reasonable certainty that no harm to human health, future generations or the environment will result from exposure to or use of the pesticide, based on its conditions or proposed conditions of registration.
